TEXT D — TEENAGERS' BEHAVIOUR

The following marking notes are to be used in conjunction with the assessment criteria included in the Language B guide.

Communicative purpose

Factual explanation/description

A. Cultural Interaction:

The aim of this task is to communicate with adults (parents).

The candidate's interest in the message should be evident.

The response should use a fairly formal register and style but this may be lightened from time to time with some informality without abandoning a serious tone.

Language accuracy is not formally assessed here and should be considered only where mistakes obscure meaning.

Although not mandatory, attempts to provide impact and reader-friendly format by using, for example, Q&A or bullet points should be rewarded.

B. Message:

All the details selected from the text should be relevant. If irrelevant details are included, this should reduce the mark awarded in line with the first bullet point in the descriptors.

Verbatim copying of short sections of the text does NOT constitute “undue copying”; the copying of sections (whether they be long or short) without using them appropriately and incorporating them sensibly into the response is what constitutes undue copying.

Candidates should select some of the following details for inclusion in the guidelines. Candidates may use their own words and do not need to use the exact wording of the details as listed below.

- parents with rude or unruly youngsters / young people / teenagers should examine their own behaviour
- if parents want their children to respect them, they must first respect their children
- the way parents treat their youngsters should vary according to the latter's age
- youngsters' opinions should count
- parents' comments to youngsters should show respect
- parents should give youngsters encouragement
- parents should give youngsters their own space
- parents should mean what they say
- parents should teach their children the right thing to do and trust them to do it
- parents should negotiate calmly and reach compromises
- parents should keep things in perspective and not over-react about trivial things such as clothes on the floor
- parents should not bring up past misdemeanours.

Criterion B:

To achieve level 5 (competent understanding) for Criterion B, the candidate should include **at least 6** details from the list above.

To achieve level 9 (thorough understanding) for Criterion B, the candidate should include **at least 8** details from the list above.
