### TEXT D — HOW U.S. TEENS MANAGE TO OBTAIN ALCOHOL

**Communicative Purpose:**

Description factual – letter to parents.

**Register and Style:**

The register should be in the range semi-formal to formal.

Language accuracy is not formally assessed here and should be considered only where mistakes obscure meaning.

**[10 marks]** should not be awarded unless the letter has

- an appropriate heading (date and greeting: Dear parents, *etc.*)
- an appropriate closing (*e.g.* yours faithfully, yours sincerely, (best) regards – followed by the signature and the sender's name under the signature).

**NOTE:** If the text is not a letter, the maximum mark it will receive is 6.

**Message:**

The aim of this task is to describe the things parents may do to help prevent alcohol abuse among their children. The candidate's concern about teens and alcohol should be evident.

The descriptors regarding copying from the text should be carefully adhered to. Verbatim copying of short sections of the text does **not** constitute “undue copying”; the copying of any section (whether it be long or short) without using it appropriately and incorporating it sensibly into the response would constitute undue copying.

The candidate should include some of the following details from the text (though not necessarily in these words):

- A. Parents can/should report establishments that sell alcohol to underage drinkers.
- B. Parents can/should report individuals who buy alcohol for minors.
- C. Parents can/should discourage the practice of obtaining fake IDs among their children.
- D. Parents can/should keep track of the amount of alcohol they have at home.
- E. Parents can/should keep alcohol under lock and key.
- F. Parents can/should buy alcohol to help their children celebrate special events under supervision.
- G. Parents can/should keep young drinkers and their friends off the roads.
- H. Parents might/should consider confiscating car keys during at-home celebrations to prevent driving under the influence.
- I. When teenagers are attending parties at another's home, parents should communicate with the host parents.
- J. Parents should make their children aware of the serious consequences of alcohol abuse and underage drinking.

**CRITERION B:**

To achieve level 5 (adequate understanding), **at least five** details should be included.

To achieve level 9 (very good understanding), **at least eight** details should be included.
